Hello all! A couple of reminders and items of interest for August from your Community Manager:

LAND LEASE UPDATE:

August 1st, the Land Lease Special Assessment was due. You can make

your payment via the ComWeb Homeowners Portal (TOPSPay or credit card) at: https://portal. goenumerate.com/login or by visiting the Desert Management website and then http://www. comwebportal.com/login.

Log in, click Bill Pay and click Pay My Bill. Please be aware that if paying in full by credit card you will need to make two transactions to pay the full amount as there is a \$7,500 PER TRANSACTION (not per day) payment limit. An approximate 3.5% third party processing fee will be added to your final amount before you confirm payment. This fee is not applied by Desert Management.

You may also pay by check. The check is payable to THE FAIRWAYS HOA with your HOA account number printed on the check memo line. Clubhouse

The compete process to acquire a cleaning service for the Clubhouse continues. Hopefully, a new vendor recommendation will be ready for the board to review at the September open meeting.

The Pool Table Room has been used for Executive Board meetings twice as intended. The table has a unique feature that allows a sectional top to convert it to a conference table. Nice option! The pool balls and cues needed to play are in the pool room. Please feel free to play, and when finished, please return items to their proper place.

Facilities

Virtually no facilities' related activities to report as the summer heat, aggravated by a number of excessive heat days, prevents projects outside from being initiated. Lighting and other miscellaneous repairs are completed as needed. A lamp post globe on Fairway Circle disintegrated and was replaced with a new one.

Pools

Unfortunately, we had a major theft at the Main pool and Spa that resulted in two pumps being stolen. The replacement cost was \$4,357, completed by **Pools by Eric**, our equipment service vendor. The invoiced amount included installation and all needed rewiring. Bill Albert stated the cost was very reasonable considering one of the pumps was replaced last year for approximately \$2,700.

Pool equipment theft is a Valley wide concern that policing agencies are targeting to hopefully reduce as reported theft incidents have increased dramatically. As a stop gap measure, Bill is recommending that a security strap be installed on all the pumps until a full review of available security options is compléted.



Noah Weinreb is also researching possible measures or anti-theft apparatus available to discourage future equipment thefts. Noah met with our vendor, Jose of JJB Pools, to discuss available options and will review and recommend possible actions to include a full cage cover over the pool equipment enclosures.

A report of a chlorine tablet present in the skimmer of one of the pools was brought to the attention of our vendor, JJB Pools, by Bill. A review of the other pools confirmed that only the one pool was involved. JJB Pools addressed the issue with the pool service techs to

insure that chlorine tablets would not be placed in the skimmers for any reason.

Tennis, Pickleball & Basketball

The Board has approved that the tennis, pickleball and basketball courts are due to be resurfaced mid September - October.

Convert Multipurpose Court to 4 Permanent pickleball courts

Scope of Work

Relocate 8 existing posts (safety concern) Add 8 new net posts and 8 new nets Remove 2 existing tennis posts and net Relocate Basketball system to adjacent tennis court Resurface and restripe all courts Install court divider posts and netting

Carports and Roofs

The beam replacement at 1756 Firestone Plaza commenced the first week of July. Unfortunately, the demolition process revealed the main beam junction with the replacement return beam was unacceptable as the end of the main beam was deteriorated and structurally unsound. The additional cost to replace the main beam is \$2,000. The cost of the return beam replacement is \$4,850 for a combined project invoice of \$6,850. This is still well below the initial **Vantage Point Construction** proposal for replacement of both the main and return beams of \$8,200 presented to the Board in March. Frank Perra worked with Vantage Point Construction to contain this cost.

The back return beam replacement approved proposal at the June Board meeting, for 6056 Fairway Circle was completed by Vantage Point Construction the third week of July for \$3,800.

A proposal to replace the forward very deteriorated brick column and 4"X4" carport support post, at 1751 Firestone Plaza, was received from Vantage Point Construction for approx \$3,200. The Board will review the proposal at the September open meeting for possible scheduling in October when Frank Perra returns for the season.

The streets here at The Fairways during the month of July have been relatively quiet. It has been unusually hot and the pavement too hot for our canines to be walked during the day. Early mornings and dusk have been the walk times of choice for us all. No personal issues have been reported needing assistance during the day.



Securitas has been made aware of the pool equipment theft during August and the parking violations. Their evening patrols have reported no unusual activity.

Parked vehicles have given us a bit of a problem....please note that there is never parking or waiting in the Red Zones at The Fairways. Reports have been made of the recent violation. Red curb markings have been strategically painted on curbs for safety especially at the entrance where Emergency Vehicles need room to maneuver and enter our property safely to respond.
